Executive Summary

This report lists all the POERUP deliverables and outputs and attempts, where appropriate, to identify their impact. The key project presentations are described in another deliverable (D5.4 – Project Presentations); this report identifies the potential impact that the project deliverables have had to date.

1 The brief

The Dissemination Report will describe how commitments have been met related to the dissemination activities, materials, planning and the obtained results, including an impact evaluation of the activities (e.g. numbers of people reached and their reactions). The structure will be determined by Deliverable 4.1 but is expected to contain:

- details of conference presentations, especially invited presentations
- reports written, especially papers for learned journals
- numbers of wiki pages, blog postings, tweets, Facebook postings, etc with information on accesses, comments, followers, friends etc.

It will also summarise dissemination routes that emerged but were not foreseen at project bid time or even project start. A possible example – based on thinking in VISCED – would be the use of POERUP project outputs in graduate courses in OER policy.

2 Introduction

This document consists of two parts, or can be considered to have two stages of completion:

The *confidential* section (or first stage), is based on questions / data copied from the <u>official EU report template</u>, intending to collect in-dept information from POERUP partners about their dissemination and exploitation activities and their circumstances. This part of the document only aims at providing a thorough overall picture of the dissemination palette and help EDEN compile the public deliverable. This intermediary document (part) will not be published with the final version of the "Dissemination Report".

The *public* part (or final stage) of the document contains information about the POERUP project, the progress of activities, production of results and services that are of public relevance. Based on partner input and the quantitative and qualitative indicators continuously and systematically collected in the <u>POERUP Dissemination Graph</u>, EDEN – together with the coordinators, University of Leicester and Sero Consulting Ltd – has finalised this part of the document.

2.1 Objectives

The overall dissemination objectives were to organise and present POERUP at events, initiate and participate in relevant discussions, subscribe to and utilise mailing lists to communicate the project outputs, write journal articles, use web 2.0 techniques to raise awareness and promote project work. The specific activities carried out during the lifespan of the project were:

- to design the project's unique visual identity (including a logo, website, and newsletter/leaflet templates);
- to create and follow a detailed dissemination plan;
- to collect and record quantitative and qualitative indicators of the dissemination activities' progress/success identified in the dissemination plan (http://tinyurl.com/POERUP-DG);
- to maintain the project website and update its content;
- to write and disseminate electronic newsletters (4 issues);
- to design and distribute printed promotional materials such as leaflets (2 rounds) and posters (2 versions);
- to <u>synergise with similar initiatives</u> identified (other EU funded projects, organizations, networks, etc.) and present the project at thematically relevant events see detailed event list in Annex 1;
- to screen suitable online social media tools, set up a Twitter account, co-author the <u>POERUP</u> wiki content and follow/contribute to relevant external online communities' activities.

All partners participated in the initial exercise of identifying relevant regional, national and international conferences and seminars where participation would be beneficial for the project. It was also considered a shared responsibility to contact and collaborate with initiatives, networks and projects that were jointly identified to have potential for synergies.

4 Dissemination

Dissemination started early in the project's lifetime – in fact the POERUP wiki was running even before the POERUP bid was submitted and the first page with content on it appeared four days after bid submission. Two months after the project formally started there was a leaflet produced for the EU Coordinators meeting in mid February 2012, and by March 2012 a systematic process of presentations at conferences had started. Furthermore, by this time the project had consolidated the pre-bid research and other OER-related work in the interregnum (between bid submission and project start) so that non-trivial results could be disseminated, unusual for a project that early in its life. It also helped that there are several experts among POERUP partners who receive many invitations to conferences across the world. Notwithstanding, it was not until late 2012 that presentations began to take on a deeply researched aspect.

This 'more researched' series of presentations started with the OER13 conference in the UK in March 2013, the EDEN conference in June 2013 (Norway), the EIF (EFQUEL Innovation Forum) in September 2013 (Granada), the Online Educa Conference in Berlin and the Media & Learning conference in Brussels in December 2013; then in 2014 there were POERUP-related presentations at OCW14 (Slovenia, April), eLSE (Romania, April), Networked Learning (Scotland, April), OER14 (England, April), and LINQ/EFQUEL Innovation Forum (Crete, May) – culminating at EDEN (Croatia, June) with a workshop on policy issues and demonstrations of the POERUP OER databases and OER Maps. A particular feature of this set of presentations was the substantial involvement (four events including a panel on policy) at OCWC14, the annual conference of the US-based Open CourseWare Consortium (now called the Open Education Consortium).

5 Reporting single actions

There have been over 30 presentations at events, mainly international ones, where POERUP has been presented or featured in a significant way. The 22 presentations which featured *substantial analytical conclusions* from the project are detailed in D5.4 – Project Presentations. See also the detailed action list in Annex 1.

6 Some conclusions

The main thrust of the original Dissemination Plan (D5.1) has been adhered to, in spite of the many difficulties the project encountered through the enforced withdrawal of a key partner half way through. Although only five of the six remaining partners made presentations at national / international conferences, the sixth partner (University of Lorraine) was deeply involved with the French ministry throughout the policy development phase of POERUP and used project analysis and research in detailed discussions with them.

The planned total of presentations was comfortably exceeded and the project extension until June 2014 made it possible to include presentations at two important conferences which would otherwise have been out of scope for this report: the LINQ/EFQUEL Innovation Forum in Crete (May) and the EDEN conference in Zagreb (June). A search of presentations on Slideshare, using 'POERUP' as the search term reveals a total of 119 presentations including references to the project.

Impact is difficult to assess immediately after the end of such a project; the main purpose was to generate policy recommendations at national and EU levels which were firmly founded in research and analysis and such recommendations take time to deliver results. During the course of the project in 2013, at the time when the Commission was preparing its *Opening Up Education* initiative, we received anecdotal evidence that the POERUP research and draft recommendations had had some influence on the content of the initiative and its Key Transformative Actions.

The project extension also enabled us to undertake a more extensive revision of the main country reports and to develop interactive maps of OER initiatives. The development of maps enabled fruitful links with a number of other current EU projects – notably eMundus – see http://www.emundusatlas.org/world.
