A Very Happy New Year to all Members of our International Advisory Committee and Welcome to our First Newsletter of 2009!

Project news

The project team are currently reviewing the country reports in the wiki which you will find listed here: www.virtualcampuses.eu/index.php/Country reports.

We are using an online evaluation form developed and managed by project partner Grégory Lucas from University of West-Hungary, College of Geoinformatics. In this evaluation, partners are checking to see if the information contained in the country reports is of appropriate quality and whether any vital aspects are missing. Once we have completed this

internal evaluation, we will be inviting external experts familiar with the countries themselves to provide their feedback including members of the IAC! To give you an example of what we are doing, we have chosen a sample from Denmark. This country report was originally prepared by project partners Nikki Cortoos and Sally Reynolds from ATIT, Belgium. Here is the part dealing with Virtual Initiatives in Denmark:

Introduction

Currently in Denmark, the term 'Virtual Campus' has fallen somewhat out of use and does not exist as an easily recognisable or identifiable term referring to any institution or particular practice. Several initiatives have been launched in the past including the Danish Virtual University and the term 'open' is used now far more to imply the use of technology to support a greater access to higher education. Furthermore several different government ministries have an interest in making university education more accessible and they each have different strategies and approaches, no centralised co-ordination amongst these programmes seems to exist. One significant player is the National IT and Telecom Agency which is run by The Ministry of Science Technology and Innovation. This agency has a national programme for e-learning for universities and research institutions. They provide seed money for specific courses and try to also encourage institutional management to become involved. 50% funding to support the development of open courseware is available from this agency not only to universities, but also to SMEs and other types of organisation. Approximately half of those applying are funded and demand for this seed funding is increasing.

The Danish Virtual University and Continuing Education at Danish Universities - A Virtual Approach

The Danish Virtual University (DVUNI) was conceived in 2000 as Denmark's response to the e-education boom in the late 1990s. The project, however, was never completed and was quietly wound up following a series of strategic failures. Following a re-think, the new Danish portal for professional development called 'Continuing Education at Danish Universities - A Virtual Approach' was launched in November 2003. The portal was established by the 12 Danish universities and encompasses all the institutions' professional development courses. The initiative is part of wider attempts to establish a closer co-operation between industry and universities, and the idea has been well received by Danish companies. The portal includes traditional campusbased courses as well as online provision (with a mix of programmes in Danish and English). In July 2004 the portal had almost 1,600 courses and 130 programmes leading to a formal qualification.

This report has been reviewed by project partners Anna-Kaarina Kairamo and Ulla Rintala from the Lifelong Learning Institute Dipoli of Helsinki University of Technology who described the information as follows: "Basic / good information in most sections except for the 'information society' part. Requires more focus on the last two sections (Country's HEIs in the information society & Virtual initiatives in HE)! Additionally, there could be more focus on higher education in general in the education descriptions. Now there is all sorts of information about the countries' grading systems etc., which we think is irrelevant." ATiT are now reviewing the information contained in the Danish country report in an effort to improve it where possible taking into account this feedback.

IAC members are warmly invited to join this process and we will be contacting specific members of the IAC with help on certain countries – but do feel free to check the reports that are there already and let us have your feedback!

History of Virtual Campus
