We are also busy gathering some of the lessons learned from the experience of researching Virtual Campus initiatives in different countries and will take the first steps towards creation of the Virtual Campus Manual, a key outcome of the project which we will have available this summer.

# **Report from World Forum**



Two of our project team, Paul Bacsich and Bieke Schreurs took part in the very first Learning and Technology World Forum (LATWF) in London on 12-14 January.

Learning and Technology World Forum 2009

About 500 policy makers and practitioners and around 70 ministers

representing two thirds of the world's population took part in this event which was organised by Becta in the UK. Speakers included internet pioneer Tim Berners-Lee, Sebastian Coe, David Blunkett, Michael Barber (Expert Partner, McKinsey), Barbara Ischinger (Director of Education, OECD) and many ministerial visitors.

Bieke Schreurs summarized her experiences at the LATWF:

# Re.ViCa at The Learning and Technology World Forum.

The Learning and Technology World Forum (LATWF) took place in London at the QE II conference centre (near Westminster) from 12-14 January 2009. The World Forum included the main World Forum event and the separate ministerial-level "Moving

Young Minds" event with more than 50 Ministers of Education.

Although the very existence of the event was meant to be kept rather confidential given the planned participation of Ministers, since the autumn the scope of the World Forum has been extended somewhat and there was a concerted effort made to

To kick start this interesting 3 day stay in London, our WP Leader Research Paul Bacsich arranged a small social get-together of ex-UKeU types on the Sunday before the World Forum started. Among these was Dick Hill, formerly of NHSU, and Jonathan Darby, now at the UKOU who is key to a number of UKOU agendas in e-learning including collaboration with the University of Derby (the UK Re.ViCa case study). So in an informal way we got a good insight into one of the key former Virtual Campus initiatives! At the Conference Re.ViCa were also involved in the workshop on "e-Impact" led by Paul. The e-Impact workshop presenters were:

- Dave O'Hare, University of Derby (Re.ViCa UK case study)

We had three working groups, all of which provided good contributions on the topics they had chosen. I participated in the one dedicated to discussing cost-issues. Although the discussion time was –as usual –too short, there may be some linkage of this

work, when written up, to our Critical Success Factors studies.

Also the BECTA Workshop on Tools for Benchmarking and
Reviewing Institutions use of ICT initiated some critical thinking.





There was probably not enough time allowed for networking. But I managed to meet e-learning experts there such as Claudio Dondi and Malcolm Read, the Executive Secretary of JISC.

I also had the opportunity to meet a strong delegation coming from the Thompson Rivers University in Canada, sharing their thoughts and insights of their study visit in the UK.



Together with them and Dick Moore we had the chance to end this very fruitful trip with "one of the things you need to have done in London": reflecting on Virtual Campuses with the background music of Ronnie Scot's jazz band.

# Sample from the wiki

To give you an example of what we have been doing in respect to write-ups of programmes of interest for researchers, we have chosen a sample from the Finnish Virtual University. This report was originally prepared by Sara Frank Bristow. You can read the full report here:

#### History

The idea of a national virtual university came from two directions: from the universities themselves and from the Ministry of Education's Strategy for Education and Research 2000 - 2004. Terms such as 'virtual university' and 'online university' started to pop up in the international and domestic university discussions at the end of 1990's. At the same time, discussion begun about the globalization of educational markets and the European Higher Education Area. In Finland, the discussion swiftly crystallized into concrete proposals:

At the 1998 term-opening ceremony of Helsinki University of Technology (TKK), rector Paavo Uronen brought up the idea of 'Finland's Online University'

At the same time, the Minister of Education of that time, Olli-Pekka Heinonen, suggested that the committee preparing for the Information Strategy for Education and Research should include a proposal for a virtual university in the strategy. Such proposal was, in fact, included in the new information strategy for 2000 - 2004.

In summer 1999, the Minister of Education Maija Rask set up an organization for implementing the strategy, including a working group on the virtual university.

The working group prepared an implementation plan, according to which the development unit of the virtual university was established in 2000.

Based on the new strategy, the Ministry of Education financed a number of virtual university projects and activities in years 2001 - 2006, and the development of FVU during that time was, indeed, rapid:

2001: FVU Consortium Agreement is signed. 2003: Nationwide Agreement on Flexible Study Rights is signed. 2004: Networks and ICT support units become part of everyday university life. Flexible Study Rights Service, JOOPAS, is launched. 2005: FVU Strategy for 2005 - 2010 is adopted. 2006: Cooperation Agreement between the Finnish Virtual University and the Bavarian Virtual University is signed. 2007: The FVU Service Unit starts operating as an independent institution of the Helsinki University of Technology, and the FVU cooperation among universities continues within the framework of the new consortium statutes.

In the implementation plan of the Information Strategy for Education and Research 2000 - 2004, there was also a mention about integrating polytechnics, companies and research institutes into the virtual university consortium. However, the polytechnics decided to launch their own 'virtual university' project at about the same time (2001), so the Finnish Virtual Polytechnic was set in motion.

# History of Virtual Campus
